Availability and pricing are applicable to the date and time at which they are quoted and cannot be guaranteed until payment is made.
Quotes in a foreign currency fluctuate with exchange rates and international payments may carry a foreign transaction fee.

Before we make or finalize arrangements for your trip, we require that you initial each term and sign below. Your signature will signify your agreement with the following terms and conditions:

- JETSET Fees: You agree to pay the non-refundable fees for services utilized, which are outlined in detail above. I acknowledge and accept there are cancellation policies, change fees, and penalties that may apply to my travel plans and services. I agree to all such cancellation policies, change fees, and penalties, and understand unused portions of travel vouchers are non-refundable.

2. **Agent for Suppliers:** JETSET World Travel, Inc. acts as a sales agent for any airline, hotel, car-rental company, tour operator, destination management company, cruise line, or other service provider named in your itinerary or confirmation (“Suppliers”). We are not responsible for the acts or omissions of the Suppliers or their failure to adhere to their own schedules, provide services or refunds, financial default, or failure to honor future trip credits. We have no special knowledge regarding the financial condition of the Suppliers and no liability for recommending a trip credit in lieu of a refund.
3. **Price Drops:** If a Supplier drops the price of a trip after booking, we will try to assist you with rebooking if the Supplier allows it, and a fee may apply. We do not guarantee any refunds or successful rebooking.
4. **Price Increases:** Travel arrangements are subject to Suppliers’ supplemental price increases that may be imposed by the supplier and/or government (even after you have completed your purchase) to cover increased costs, fuel surcharges, tariffs and taxes, and to reflect fluctuations in foreign exchange markets. You hereby consent to any such price increases and authorize your credit or debit card to be used for them. Suppliers have their own contracts covering cancellation penalties and other terms and conditions, and you may be bound by those contracts regardless of whether you receive notice of their terms.
5. **Flight Confirmation:** Fares are subject to availability and prices may change after the date of ticketing including price for baggage, applicable fuel surcharges, or an increase in a government-imposed fee or tax. **Passport copies for all travelers are required to confirm international air reservations.**
6. **Foreign Entry Rules:** You assume full and complete responsibility for checking and verifying any and all passport, visa, vaccination, or other entry requirements of your destination and your connecting points, and all conditions regarding health, safety, security, political stability, and labor or civil unrest at such destination.
  - Many countries require your passport to be valid for six months or more after your date of entry.
  - Some countries will not admit persons convicted of a crime.
  - Some countries require both parents’ consent for minors to travel.
  - Some countries require that your passport have two to four blank visa/stamp pages. Some airlines will not allow you to board if this requirement is not met [www.travel.state.gov/content/passports/en/passports/FAQs.html](http://www.travel.state.gov/content/passports/en/passports/FAQs.html).
  - When travelling domestically or internationally, the U.S. Transportation Security Administration (TSA) and U.S. Department of Homeland Security (DHS) advise that everyone carry at least two forms of acceptable identification in order to board a flight <https://www.tsa.gov/travel/security-screening/identification>.
  - The name, date of birth and gender that appears on the identification card must exactly match the same such data that is listed on airline ticket(s) and booking records.
  - Additionally, a visa and vaccinations may be required. Please note that even when a visa is issued, a traveler may be denied entry since each country’s local immigration officials make the final entry decision. Several factors including past criminal record may contribute to the decision of the local immigration official(s). Should a visa not be issued, Jet Set World Travel is not responsible for lost payments made toward the contemplated trip.
  - If traveling to or through Canada, travelers with a Driving While Intoxicated (DWI) or other conviction record should always check whether current rules exclude admission. certificates), health hazards, and other restrictions regarding travel to your domestic and/or international destination(s), and re-entry into the United States.

- Required or advised inoculations you decide to obtain upon the advice of your personal physician may need to be administered in a series of doses months ahead of your planned departure and such time element should be taken into account by you when making deposits and/or nonrefundable final payments. - The Smart Traveler Enrollment Program (STEP) is a free service provided by the U.S. Government to U.S. citizens who are traveling to, or living in, a foreign country. STEP allows you to enter information about your upcoming trip abroad so that the Department of State can better assist you in an emergency. Registration is recommended and provided by going to [www.step.state.gov/step](http://www.step.state.gov/step).

**7. Credit Card Merchant:** We also strongly recommend that you use a credit card for your purchase, so that you can exercise your rights under the Fair Credit Billing Act if you do not receive the services you purchased. However, if we are the credit card merchant, our role is to facilitate the sale, collect funds on your behalf, and remit those funds to the Suppliers. If the Suppliers do not provide the services, your only recourse would be against the Suppliers, and you agree not to initiate a chargeback against us. If for any reason my credit card charges are later declined, reversed, or Jet Set World Travel is unable to receive payment for the travel plans and services, I acknowledge that this is a binding contract between myself and Jet Set World Travel, and Jet Set World Travel shall be entitled to recovery, including reasonable attorneys' fees in connection with collection.

**8. Insurance:** For your protection, we strongly recommend that you purchase trip cancellation and travel accident insurance to help protect passengers and their investment. Insurance is NOT automatically included in the cost of an itinerary to protect against third party default, delay, trip interruption, trip cancellation, emergency medical expenses, emergency medical evacuation/repatriation, baggage loss, baggage delay, and more. Please note that most policies have a specific clause stating they do not cover epidemics and pandemics, especially when travel warnings are in place. No representation or description of the insurance made by our staff constitutes a binding assurance or promise about the insurance. You agree to hold us harmless for your election not to purchase travel insurance or for any denial of claim by travel insurer as it relates to Covid-19 or any other claim under the policy.

**9. Claims Deadline and Exclusive Jurisdiction:** You agree to present any claims against us within 30 days after your trip ends and to file suit within one year of the incident, and you acknowledge that this expressly limits the applicable statute of limitations to one year. You agree that the courts in Cook County, Illinois will be the exclusive jurisdiction for all claims brought by you or us, and you hereby submit to the personal jurisdiction of those courts.
